**JOINT REPORT OF LEAD PLAINTIFF, THE REGENTS OF THE UNIVERSITY OF  
CALIFORNIA AND THE RUBEN PARTIES PURSUANT TO THE COURT'S MARCH  
3, 2008 ORDER (DOCKET NO. 5925)**

Pursuant to this Court's March 3, 2008 Order (Docket No. 5925), Lead Plaintiff, The Regents of the University of California ("The Regents") and Richard Ruben and approximately 20 other individuals or related entities (collectively, the "Ruben Parties") submit this report regarding their efforts to resolve their issues with respect to the Plan of Allocation currently before the Court for approval. Since the Court's March 3, 2008 Order, The Regents and the Ruben Parties have engaged in extensive discussions and negotiations and have exchanged additional information and undertaken due diligence regarding the specifics of the claims of the Ruben Parties. They are pleased to report that an agreement has been reached with respect to those claims. This agreement acknowledges that the claims of the Ruben Parties are covered by the Plan of Allocation as currently written, that no change to the Plan of Allocation is necessary to resolve the objections of the Ruben Parties, and that the aggregate Recognized Claim (as defined in and calculated pursuant to the Plan of Allocation) of the Ruben Parties is approximately \$45 million. Accordingly, the Ruben Parties withdraw all objections to the Plan of Allocation and The Regents and the Ruben Parties respectfully request that the Court approve the Plan of Allocation in its current form.

On a separate issue, The Regents hereby reports that it has scheduled two open meetings, on March 27 and 29, 2008, in Houston, for Enron class members. Representatives of Lead Counsel and the Claims Administrator, Gilardi & Co. LLC, will be in attendance to answer questions regarding the Plan of Allocation and the Proof of Claim form. A copy of the announcement for these meetings is attached as Exhibit A.
